Tract Description: The property is located near the community of Lapile in southeast Union County. Access is via woods haul roads.

The topography is gently rolling and well drained. The soil types are Sacul-Sawyer complex and Harleston fine sandy loam. Based on the NRCS Web Soil Survey the average site index for loblolly pine is 90 feet (base age 50). All merchantable timber was harvested in 2022 and the tract is currently ready for reforestation. This property is located in an area than generally offers excellent deer and turkey hunting!

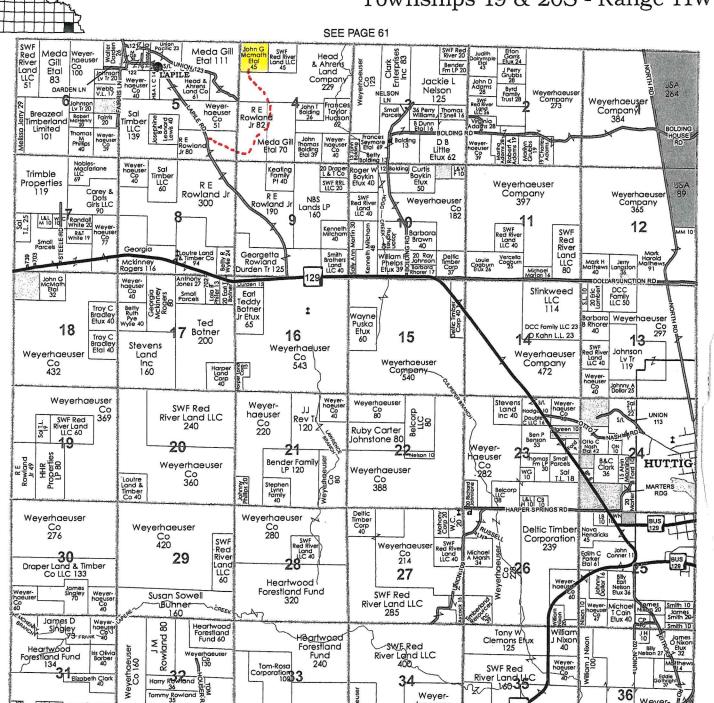
